For Unaccompanied Guests participating in Golf, Tennis and/or Fitness the guest card fee is included in the respective user fee, and Unaccompanied Guest Cards will be provided on the day of play at Golf, Tennis, or Fitness/Administration. For access to all other Club facilities, Unaccompanied Guest cards are \$5 per day (currently lemon yellow in color), \$18 per week (currently teal in color) and \$18 times the number of weeks desired = extended (currently red in color). In addition to the guest card fee, Unaccompanied Guests pay appropriate user fees where applicable. Unaccompanied Guest cards are required for all persons age 5 and over.

In order to use any Club facilities, Unaccompanied Guests are required to purchase a guest card and/or pay user fees. Unaccompanied Guests may make a reservation for Golf and/or Tennis two days in advance. Time of day use restrictions apply for Golf and Fitness from the Saturday before Memorial Day thru Labor Day. Play or use may begin in Golf after 12 noon, and the Fitness Center is closed to Unaccompanied Guests between the hours of 8 am and 12 noon. Beech Mountain Club restricts payment to Mastercard or Visa only.

Guest Policies & Procedures

Accompanied Guests – Members are welcome to accompany their guests while they are using any Club facility and there is **no need for accompanied guests to have guest cards.**

Family Guests – defined as parents, grandparents, children over age 23 and grandchildren (Siblings are excluded from the Family Guest distinction).

1. Family guest cards are **free of charge** (currently violet in color), and **issued upon request through the Membership & Member Services offices** located respectively in Administration and Recreation buildings.
2. **A member must initiate the request and acquire cards** for Family guests. Family guest cards are valid for up to one year and expire April 30th each year.
3. Family guests pay appropriate user fees where applicable.

Unaccompanied Guests – defined as all qualified guests (renting Club membership property) other than Accompanied or Family.

1. Unaccompanied guest cards are provided and/or sold to qualified Unaccompanied Guests. To qualify (sponsor) an Unaccompanied Guest, **a member must initiate the request and reserve the cards 72 hours in advance.** To initiate the request, **a member must complete the Unaccompanied Guest Request Application** available on the Club website and/or in both the Membership and Member Services offices located respectively in Administration and Recreation buildings and deliver the form in person, via fax to 828-387-2204, or via e-mail to beechmtclubmembership@yahoo.com.
2. For Unaccompanied Guests participating in Golf, Tennis and/or Fitness the guest card fee is included in the respective user fee, and Unaccompanied Guest Cards will be provided on the day of play at Golf, Tennis, or Fitness/Administration. For access to all other Club facilities, Unaccompanied Guest Cards will be held at the location requested by the Guest.
3. Unaccompanied Guest Cards are \$5 per day (currently lemon yellow in color), \$18 per week (currently teal in color) and \$18 times the number of weeks desired = extended (currently red in color).
4. In addition to the guest card fee, Unaccompanied Guests pay appropriate user fees where applicable.
